## Canada's Most Powerful Women in 2011 announced by the Women's Executive Network

**Ninth annual Top 100 Awards and Summit celebrates the professional achievements of women across Canada**

TORONTO, Dec. 1, 2011 /CNW/ - The Women's Executive Network (WXN) today announced the recipients of 2011 Canada's Most Powerful Women: Top 100 Awards, celebrating the professional achievements of women across the country.

Award Winners and Hall of Fame inductees will also be honoured in their own communities of Vancouver and Calgary in 2012.
